The office which he helped
to found – along with two
brave volunteers from the
Vienna office (Günther
Horvath and Willibald
Plesser), plus Czech lawyer
Josef Vejmelka and Miluska
Vrzackova – now has around

15 lawyers, and clients like Ford, Interbrew, Lego, Microsoft, Merck Sharp Dohme, General Electric, Bank Austria, Creditanstalt and UPS.

As Josef Vejmelka explains: "Our Prague office began in leased premises in a private apartment filled by an art collection almost as rich as the national museum's. But we soon found ourselves moving to a new office, after our first landlord decided he did not want us to step on his carpets, move his chairs or meet clients on his premises.

"The second choice of location appeared to be the right one – leaving aside the fact that our new landlord had been shot for unknown reasons – although we had two lawyers using a kitchen for an office, which led to delicious and spicy

legal opinions. But all good things happen three times, and we moved into our current offices in 1993."

Since 1990, the number of fee-earners and other staff has increased to 25 and, more importantly, the number of clients has grown just as dramatically. Practising law in the early days was far from easy – the law was changing so quickly that sometimes the amendments were changed even before they were published. Moreover, hundreds of new statutes were adopted without any clue as to their interpretation, while investors waited at the door. It was a very exciting time for legal advisers.

## **BRATISLAVA**

As we approach the ten-year anniversary of our Bratislava office's opening in February 1991, we have witnessed truly dramatic historical changes in the country. Slovakia is a relative newcomer on the stage of democracies, having become independent after the Velvet Revolution against communism and the 'Velvet Divorce' from the Czech Republic in 1993. Once criticised for its focus inwards, it is now an up-and-coming nation, aspiring to become a full member of the EU, and our Bratislava office works for such familiar companies as Microsoft, Nordzucker, Neuber Slovakia, Biotronic, Dura AG and Holderbank.

Our legal staff has grown from two to ten in number, making us a large office by Slovak legal standards. This growth has also allowed us increasingly to handle more sophisticated matters. One of the best examples of this is the upcoming privatisation of the gas company SPP, Slovakia's largest-ever privatisation. Supported by Jon Rees in London and Paul Luiki in Vienna, and others from our London and Brussels offices, the Bratislava team recently pitched for a project to represent a consortium of Ruhrgas, Gaz de France and Snam, knowing that they were in stiff competition with at least three other law firms. Shortly before Christmas, the magic words appeared on the office fax machine: "Following our meeting in Bratislava, we have the pleasure to inform you that the Consortium has chosen Freshfields Bruckhaus Deringer as external counsel for the SPP project." The SPP project promises to be one of our major projects in Bratislava

"One thing we have been very successful in generally," says Dana Martinková, head of our English-speaking client team, "is taking control of drafting documents, whether we represent buyers or sellers. This has given us a decided advantage in negotiating deals." This may not be so easy in the SPP privatisation. "White & Case is representing the government and will likely be conducting an auction process. We and the consortium will have the challenge of conducting thorough and informative due diligence while taking a balanced approach to the purchase contract. Seeking too much contractual protection can backfire in an auction process."
